HOCKLEY HEATH PARISH COUNCIL FINANCES EXPLAINED

Prior to 2009, Hockley Heath Parish Council included the areas of Cheswick Green, Tidbury Green, Dickens Heath and Hockley Heath. Following issues regarding the unwieldy size of the parish council and efficiency in each village, Solihull Council divided the parish council into four – each one representing a village and its hinterland. **Since 2009** Hockley Heath Parish Council now only represents the residents of the village of Hockley Heath and immediate rural area – a population of around 1,450.

Below is a table as a guide to show how roles and responsibilities have changed with this reorganisation:

As the Parish Council has become more local focused, so it is easier to see how the Precept is being utilised. The financial table clearly identifies the operating costs from discretionary costs.

Operating Costs: these are the items of work which the Parish Council must undertake in order to provide a safe community facility in the recreation ground, playground, woodland and bowls club. In addition, there are administrative costs associated with operating these facilities and supporting councillors.

Discretionary Costs: these are areas of work which have been raised by the community through the village plan and ongoing requests, which the Parish Council would like to see undertaken. It may not be possible to fund these activities in one year but as the council becomes more adept at seeking grant funding, it is hoped that the work will take place.

Reserves: it is prudent for parish councils to hold a reserve for emergency expenses e.g. fighting a significant planning application. HHPC would ideally like a reserve of no less that £20,000.
